

2024 Lake Lotawana 5-Stand Sporting Clays League



June 1st through September 28 2024

Details

- **50 Targets per month for 4 months – Total 200 targets**
- **Shooter must specify league round prior to shooting, and a special league score sheets(s) must be used and signed by shooter.**
- **Target presentations will be changed each month, shooters must shoot all 4 sets of targets to be eligible for prize money.**
- **Target change dates will be announced by the club.**
- **\$100.00 buy in with 75% pay back as 50% / 30% / 20% in three groups 1 _ 2 _ 3**
- **Practice each target set and much as possible \$12 for 25 targets**
- **League rounds cost \$24.00 for 50 targets**
- **This is a non-registered fun league open to all skill levels**
- **Shooters are allowed to fall behind one month, should this occur then their lowest recorded score will be used in place of that missing months score. Targets cannot be made up once course change has occurred. Its highly encouraged to stay current with this league.**
- **League rounds can be shot from 4pm on Wednesdays & Fridays or Saturday and Sunday during normal business hours.**
- **League rounds or practice cannot be shot on Tuesdays and Thursdays**

Fine Details

- This league runs from June 1st through September 28, 2024
- Each Shooter must shoot 50 Targets per month completing all 4 sets of target presentations for a total of 200.
- Target presentations will be changed each month.
- Target change dates will be announced so shooters can plan their schedule.
- Targets will be shot on 50 target menus all Report Pairs
- Standard NSCA Sporting Clays Rules apply, here are some rules in particular:
 - If a shooter calls for a target and fails to shoot because he/she were unaware of where that target was coming from that is considered a lost target. Shooters must pay close attention to the menu.
 - Targets will be thrown as report only
 - Failure to fire because a safety is on is ruled a lost target
 - During shooter rotation all guns must be completely unloaded with actions locked open during the move
 - Only two shells are allowed in the gun at one time
 - Maximum load is 11/8 of 7.5 shot
 - Chokes may not be changed once the round has started
- Shooter buy in is \$100.00 with 75% pay back in 1st, 2nd, 3rd places in three groups
- The three groups will be 1 – 2 – 3 based on score ranking (see example) this keeps shooters with similar skills competing against one another. This also creates 9 payout slots.
- Shooters are highly encouraged to perform at their highest potential. No sandbagging allowed, once a shooter is assigned a group he/she will remain there for the duration on the 4 month time frame.
- This league is won and lost based on a total number of targets broken by the shooter over the 4 month time frame within their assigned group. There is a maximum score of 200 .. i.e. 50 targets x 4 months = 200 targets
- Ties are settled by longest run
- Targets can be practiced as many times as a shooter wants prior to designating his/her official league round, which will be scored on specific score sheets and filed in the clubhouse.
- Pricing is \$12 for practice 25 targets
- Shooters cannot shoot 5-Stand on Tuesdays and Thursdays as it interferes with Trap Leagues
- Club only provides score keepers/ pullers on Saturdays and Sundays.

- 2. Second set of targets start July 2nd**
- 3. Third set of targets start August 1st**
- 4. Fourth set of targets start September 2nd**
- 5. Last day to shoot Wednesday September 28th**
